Sub.: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Hisri New Bauxite mine (area 19.58 Hects.) in Lohardaga district, Jharkhand State.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated during the inspection of your above mine carried out on 16.08.2021 by Shri B.L. Kisku, Assistant Mining Engineer, Indian Bureau of Mines, Ranchi.

Rule No.	Nature of violation observed in detail

Rule-II(1):	No holder of a mining lease shall commence or carry out mining operation in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government

In your case, mining operations are not carried out in accordance with approved review of mining plan approved vide letter no.: RAN/LOH/BX/MP-24/2019-20, dated 19/03/2020 to the extent indicated below:

(i) At Chapter – 8.0; Para – 8.3.5; page - 63: Summary for year-wise proposal (for 2020-21): It was proposed to carry out the reclamation & rehabilitation work during 2020-21 in 0.49 ha. in south-eastern part of mining lease boundary, whereas, actual work done was 0.183 hect. only.

The reason for deviation may be furnished.

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule-62 of MCDR-2017. **The relevant extract of the rule 62 is given below:**

“62 Penalty: - Whoever contravenes any of the provisions of these rules shall be punishable with imprisonment for a term which may extend to two years or with fine which may extend to five lakh rupees, or with both, and in the case of a continuing contravention, with additional fine which may extend to fifty thousand rupees for every day during which such contravention continues after conviction for the first such contravention.

03. You are, therefore, advised to rectify the above violations immediately and intimate the position to this office within 45(forty five) days from the date of issue of this letter.


