On the examination of this office records, it is observed that the following provisions of Mineral Conservation & Development Rules, 2017 are violated in respect of your above referred

2. It is brought to your kind notice that, if it is found that the holder of mining lease has submitted incomplete and wrong information in monthly or annual returns and if the above rules are not complied; the Regional Controller of Mines may advise to State Government to take following action under rule 45(7)(a) of Mineral Conservation and Development Rule, 2017:

order suspension of all mining operations in the mine and to revoke the order of suspension only after ensuring proper compliance;

take action to initiate prosecution under these rules;

recommend termination of the mining lease, in case such suppression or misrepresentation of Information indicates abetment or connivance of illegal mining;

3. You are, therefore, advised to rectify the above violations immediately and intimate the position to this office within 45(forty five) days from the date of issue of this letter.
