Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Naganapur Limestone Mine (M.L.No.2480) over an extent of 1.62 Ha. situated in Naganapur Village, Mudhol Taluka, Bagalkot District of Karnataka State.

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 12.08.2022 by Shri. Vidyadhar V. Tari, Asstt. Mining Engineer of this office in presence of S/shri G.Harendra, Technical Qualified Person and Shri. Kashappa N.Kilardar, Mines Mate of M.L.No. 2358 of Shri. H.G.Shreepada.

Rule No.	Nature of Violation observed
28	During the inspection of mine it was reported that the mine is not working since 2015-16. However, notice of temporary discontinuance of mine in "Form-E" as required under this rule is not found submitted to this office.
34A(2)	Soft copy of high-resolution Georeferenced Ortho-rectified Multispectral satellite images of the leased area and upto hundred metres outside the lease boundary taken in the month of April to June of 2022 is not found submitted to this office as required under this rule.

45(5)(c)(i)	Annual Return for the F.Y. 2020-21 and 2021-22 required to be submitted before 1 st day of July for the preceding financial year is not found submitted to this office.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable as per the provisions of Rule 62(1) of Mineral Conservations and Development (Amendment) Rules, 2021 notified on 03.11.2021. Amount to be paid as fine in case of violation of aforesaid rules is mentioned in Schedule-II & III of MCD(Amendment) Rules, 2021.
03. The mining operations can be suspended under Rule 45(7) of Mineral Conservation & Development Rules, 2017, if compliance of Rule 45(5) is not found satisfactory.
04. You are, therefore, advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
