Sub: - Violation of the provisions of MCDR, 2017 in respect of your Lumshnong Limestone Mine (38MEG03001) over an area of 4.20 Ha. in East Jaintia Hills Dist. of Meghalaya state.

Ref: - Your email dtd. 22.9.2020, enclosing kml files of the land use data of the aforesaid ML.

Sir,

On perusal of this office record, following provisions of MCDR 2017 have been found violated in your above mine –

Rule No.	Nature of violation observed
11(1) : No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub section (2) of section 5 or approved by the competent authority of the Atomic Minerals Directorate for Exploration and Research, in respect of the minerals specified in Part B of the First Schedule to the Act where the Grade of such atomic minerals is equal to or above the threshold value limits declared under Schedule-A of the Atomic Mineral Concession Rules, 2016.	<p>The review of mining plan of the aforesaid ML for the period 2017-18 to 2021-22 was approved by this office vide letter No. IBM/GHY/MEG/JNH/LST/MS-73 dtd. 27.2.2017. A copy of the last updated surface plan was also submitted by you on 6.12.2018.</p> <p>The land use data of the aforesaid mine in kml file format was submitted on 22.9.2020 against this office email enclosing letter No. IBM/GHY/153/2017/TECH/MTS dtd. 3.9.2020.</p> <p>On perusal of the above information, it is clearly observed that the shape of the ML as per the approved mining plan & the last submitted surface plan as on 6.12.2018 is in abeyance to the kml file of the ML boundary as submitted by you vide the aforesaid letter under reference.</p>

- 02 In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR 2017.
- 03 The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04 You are therefore directed to show cause within a period of 30 (Thirty) days from the date of issue of this letter, as why you should not be prosecuted for the above offence.
- 05 Please note that no further notice will be given to you in this regard.
