Sub: Violation of provisions of MCDR, 2017 in respect of your Devada Manganese Mine over an extent of 41.054 ha. situated in Devada Village, Gurla Mandals, Vizianagaram District of Andhra Pradesh State.

The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in the above mine during the inspection on 25/08/2022 by the undersigned in presence of the mine officials Shri Addala Vishwanath Naidu, Manager (Mines) and Shri Songala Appala Naidu, Mining Engineer.

Rule No.	Nature of violation
Rule 26 (2)	A yearly report as per the format specified by the Indian Bureau of Mines, before 1st day of July every year setting forth the extent of protective and rehabilative works carried out has not been submitted for the year $\frac{2019-20}{2021-22}$.
Rule 33	A dgital copy alongwith a print copy of the surface geological plan and sections has not been submitted on or before 30th day of June to the authorised officer for the financial year 2021-22.
Rule 46	Notice of Certain Appointment: Appointment notice of the Agent (Mines) has not been sent in the prescribed format (Form H) to the authorized officer within fifteen days from the date of such appointment.

02. In this connection, it is brought to your notice that the violation of aforesaid rule constitutes an offence, punishable under Rule 62(1) of MCDR, 2017. as well as Fine may be imposed as specified under Schedule-III of rule 62(2) of MCDR, 2017 Amended up to 3rd November 2021.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
