The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection for processing of Review of Mining plan on 12.4.2021 by Smt. Ch. Suseela, Assistant Mining Geologist of this office accompanied by your good self and Sri. V.T. Chander, Qualified person
