- 3. The mining operations may be suspended under the rule 11(2) of MCDR-2017, if compliance of the pending rule 11(1) of MCDR-2017 is not found satisfactory. 4. You are, therefore, directed to show cause within a period of 30 (thirty) days from the date of issue of this
- letter, as to why you should not be prosecuted for the above offence.
- 5. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017. 6. Please note that no further notice will be given to you in this regard.
