The following provisions of the Mineral Conservation and Development Rules 2017 were found violated in your above mine during the inspection on 20.09.2021 by Sh. Jay Kumar Pandey, Assistant Mining Engineer, accompanied by Sh. P.D.Awasthi, representative of lessee & Sh. Abhisek Tiwari, Mining Engineer.

Rule 26(2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1 <sup>st</sup> day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof.  Lessee has not submitted annual PMCP report for the reporting year (2020-21).
Rule 33	Copies of plans and sections to be submitted – The holder of mining lease shall on or before the 30th day of the June every year submit to the authorized officer, as the case may be, and the State Govt. a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32.
	Copies of plans and sections under rule 32 of MCDR-2017 have not been submitted.
Rule 46	The holder of the prospecting licence or prospecting license cum mining lease or the mining lease shall,—when any new appointment of an agent, mining engineer, geologist or any person is made under sub-rule (1) of rule 55; or  (b) when the employment of any such person is terminated or any such person leaves the said employment; or  (c) when any change occurs in the address of any such person, within fifteen days from the date of such appointment, termination, leaving or change in address, give a notice in Form H of the Schedule to the authorised officer, as the case may be.  Appointment notice of Mining engineer was not sent to the Regional Controller of Mine, Jabalpur till the date of inspection.
Rule 48(1)	The holder of a mining lease or the holder of a prospecting licence or prospecting license-cum-mining lease shall keep a record in Form-J of all shafts or boreholes and shall retain such records and preserve the samples of the strata passed through for a period of not less than twelve months after the completion of the work or abandonment thereof:  Record of boreholes in form J were not maintained & provided for verification during inspection.

- 2. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- 3. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
