Sub: Violation of the provisions of MCDR, 2017 in respect of your Wah-Pynkon Limestone Mine-II (38MEG03017) over an area of 13.58 Ha. in Lumshnong Village, Taluka- Khliehriat, East Jaintia Hills district of Meghalaya State.

Sir,

On perusal of this office record, following provisions of MCDR 2017 have been found violated in your above mine –

Rule No.	Nature of violation observed
11(4): The Holder of mining lease shall submit the mining plan to the competent authority for review at least 180 days before the expiry of five years period for which it was approved on the last occasion, for mining operations for period of five subsequent years.	Wah-Pynkon Limestone Mine-II over an area of 13.58 Ha. in East Jaintia Hills district of Meghalaya State is valid up to 31.03.2021 and the next review is due for its submission.

- O2 In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.
- The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- You are therefore advised to rectify the above violation immediately and intimate the position to this office within a period of 45 (Forty Five) days from the date of issue of this letter.
