Sub: Violation of provisions of MCDR, 2017 in respect of your Khandabandh Iron Ore mine, over an area of 35.774 hectare in Keonjhar district of Odisha.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above said mine during inspection on 11.09.2018 by the undersigned and Shri Dilip Jain, JMG, accompanied by S/Shri M.K.Mohanty, Mines Manager, R.K.Moharana, Geologist of your mine.

11 (1)	As per the approved mining scheme dated 08/08/2008, i) It is proposed to the development in the initial 3 years adjacent to the existing quarries called FQ-2&3, as a lateral development towards eastern side.	i) During inspection it is observed that the development has been carried out at different location which was not proposed in the approved mining plan.
26 (2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof.	A yearly report for the year 2017-18 as per the format specified by the Indian Bureau of Mines, setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan has not been submitted till date to this office.
67	The holder of a mineral concession shall furnish such information regarding his reconnaissance or prospecting operations or mining operations or any matter connected therewith as the authorised officer may require by an order in writing and the information shall be furnished within such time as may be specified in the such order.	approved mining plan for the year 2017-18 has not been submitted till date to this office.

02. It is brought to your notice that these violations constitute an offence punishable under Rule 62 of MCDR, 2017.
