Sub: Violation of provisions of MCDR, 2017 in respect of your Jaribahal Iron ore Mines, over an area of 106.533 hectare in Keonjhar district of Odisha.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above said mine during inspection on 12.09.2018 by the undersigned and Shri Dilip Jain, JMG, accompanied by S/Shri Antaryami Sahoo, Senior Inspector of Mines (Joda Circle), Bhabagrahi Mohapatra. Geologist of your mine.

Rule No.	Proposed in the approved mining plan / Rule	Violation
14 (3)	The overburden and waste material obtained during operations shall not be allowed to be mixed with the materials specified in sub rule (1) i.e. non saleable ore.	During inspection it is observed that the waste generated from quarry-9 of the mine operations are dumped over sub grade stack near to the proposed process plant, whereas both should not be mixed.
45 (5) (c) (i)	Annual Return which shall be submitted before the 1 <sup>st</sup> July each year for the preceding financial year.	Annual return for the year 2017-18 has not been received till date to this office within the specified date i.e. by the 1 <sup>st</sup> July 2018 of respective preceding financial year.

02. It is brought to your notice that these violations constitute an offence punishable under Rule 62 of MCDR, 2017.

Further, in view of the above position, the information furnished under Rule 45(5) in the Annual return is construed as furnishing wrong or false information, which leads this office to advise the state government under rule 45 (7) to,-

- (i) Order suspension of all mining operations in the mine and to revoke the order of suspension only after ensuring proper compliance;
- ii) Take action to initiate prosecution under these rules;
- (iii) Recommend termination of the mining lease, in case such suppression or misrepresentation of information indicates abetment or connivance of illegal mining;
- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
