Subject: Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect of your Umsoo Mootang Block-I limestone mine over an extent of 4.9 Ha. in Jaintia Hills district of Meghalaya.

Sir,

On perusal of the office records, the following provisions of MCDR, 2017 were found violated in your above mine.

Rule Number	Nature of violations observed
11(4): The holder of a mining lease shall submit the mining plan to the competent authority for review atleast 180 days before the expiry of 5 years period for which it was approved on the last occasion, for mining operations for a period of 5 subsequent years.	The existing review of mining plan is valid upto 31.3.2019 and next review was due for submission on 2.10.18. But, till date no draft review of mining plan for carrying out the mining operations in subsequent years has been received in this office.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
