**Subject**: Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect of your Mawlong limestone mine over an area of 4.56 Ha. in East Khasi Hills district of Meghalaya.

**Reference**: Our letter dtd. 23.8.2018 seeking copies of delivery challans & letter dtd. 1.10.2018 seeking certified copies of the submitted challans from customs dept.

Sir,

With reference to the cited letters, following provisions of MCDR, 2017 were found violated in your above mine.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. If the above rules are not complied; The Regional Controller of Mines may advise to State Government to take following action under rule 45(7)(a):

(i) Order suspension of all mining operations in the mine and to revoke the order of suspension only after ensuring proper compliance;

(ii) Take action to initiate prosecution under these rules;

(iii) Recommend termination of the mining lease, in case such suppression or misrepresentation of information indicates abetment or connivance of illegal mining.

04. You are, therefore, directed to show cause within a period of 30 days from the date of issue of this letter, as to why you should not be prosecuted for the above offences.

05. Please note that no further notice will be given to you in this regard
