Sub: Violation of provisions of MCDR, 1988 in respect of Beechupall Limestone Mine of M/s. Beechupalli Minerals & chemicals, over an extent of 2.084 ha, in Malkapuram Village, Dhone Mandal, Kurnool District, Andhra Pradesh State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 1988 (amended in 2011) were found violated in the above mine during the inspection on 27-10-2015 by Sri P Guruvaiah, Asst. Mining Geologist of this office in the presence of mine official Sri B. Narasimha Reddy, Mine Representative.

Rule No.	Nature of violation observed
45(5)(a)(viii)	Monthly Returns in Form F-8 since April 2015 to September 2015 have not been submitted to the Regional Controller of Mines, IBM, Hyderabad till date as required under this rule. The Monthly Returns should be submitted before 15th of every month in respect of preceding month.
45(5)(b)(viii)	Annual Returns in Form H-8, for the year 2012-13 to 2014-15 have not been submitted to the Regional Controller of Mines, IBM, Hyderabad till date as required under this rule. The Annual Returns should be submitted before 1st July of every year in respect of preceding year.

02. In this connection, it is brought to your notice that the above said violations also constitute an offence punishable under Rule-58 of MCDR, 1988.
03. The mining operations can be suspended under rule 45(7)(1)(a) if compliance of Rule 45(5)(a)(viii) & 45(5)(b)(viii) found not satisfactory.
04. You are, therefore, directed to **show cause** within a period of 30 (thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence or mining operations suspended under Rule 45(7)(1)(a) of MCDR, 1988.
05. Please note that no further notice will be given to you in this regard.
