02.You are advised to attend the deficiencies as per the annexure and resubmit the document, complete in all respects, in three bound copies along with soft copy in the form of CD (2Nos.). In this regard, you are directed to submit the Financial Assurance in the form of Bank Guarantee for the area put on use for Mining and allied activities @ RsThree lakhs/hectare for category 'A' mines provided that the minimum amount shall be Rs.Ten lakhs as per the provision of Rule 27(1) of MCDR, 2017 at the time of submission of final copies of the document within 15 (fifteen) days from the date of issue of this letter, failing which the document will be disposed without giving any further opportunity.

03. The para-wise clarification & the manner in which the deficiencies are attended should be given while forwarding modified document.

**Scrutiny comments on Review of Mining Plan of Choutapalli Limestone Mine-II of M/s. My Home Industries Private Ltd. over an area of 156.586 hectares in Mellacheruvu village & Mandal, Suryapet District, Telangana.**

**General**

1. In the cover page, proposal period shall be corrected as (from 2021-22 to 2025-25) i.e., for 5 years period only.
2. Mine name shall be submitted correctly in the cover page.
3. Consent letter/undertaking/certification by the applicant shall be on Company's original letter head duly signed with date
4. Certificate by Qualified Person should be on company's original letter head, duly signed since he is working in the company presently.
5. Approved EC quantity of all the mining leases linked to the plant shall be submitted.
6. Mine code be mentioned in the cover page and in the lessee details in page no.9.
7. Limestone consumption factor report shall be submitted.
8. Color photographs should be enclosed in the document for easy reference pertaining to boundary pillars, working pit, afforestation, core logs, ground control points etc.
9. Experience Certificate of the Qualified Person as per rule 15 (1) (b) of MCR 2016 shall be submitted.

**Review of Mining plan**

10. Review for the earlier plan period (2016-17 to 2020-21) shall be submitted.
11. Proper justification for deviation in the yearwise proposed development, production shall be submitted.
12. Status of compliance of violations pointed out by IBM shall be submitted correctly

**Geology and Exploration**

13. Average grade of the various types of limestone in the lithology units shall be submitted.
14. Lithology wise limestone quantity and weighted average grade of total deposit shall be submitted.
15. Summary of Phase wise exploration carried out in the lease area should be furnished in tabular form.
16. The UNFC classification codes shall be mentioned correctly in the geological sections and Reserves/Resources shall be estimated accordingly.
17. Resource under 211 (Feasibility Mineral Resources) category shall be submitted in the Total Reserves and Resources table in page no.48.

**Mining**

18. Development and production proposal for the Review of Mining Plan period from 01.04.2021 to 31.03.2020 only be submitted.
19. Specifications & details of the machineries like model, imported/exported, digging height etc., shall be submitted.
20. Blast vibration monitoring details as per DGMS (B) standards also be submitted.
21. Complete report of the Blast vibration studies shall be submitted.
22. Railway Line over bridge and NSP canal were present near the mining lease and in the Controlled blasting technique report shows maximum charge per delay is 54kg is suggested, whereas the blast vibration monitoring report shows a MCD of 200kgs is used.

**Conceptual plan**

23. Proposed tonnage at the end of this 5 year period and upto the end of the lease period shall be discussed in the Conceptual Mine Planning chapter.



24. Conceptual planning of excavation, plantation etc., shall be submitted from the financial year 2020-2021 in page no.62 and 63.
25. Five year plan period years shall be submitted correctly in page no.62 and 63 in the Conceptual Mine Planning chapter.
26. Life of the mine based on the proposed production/mine capacity be submitted.

#### **Mine Drainage**

27. Likely make of water quantity into the pit shall be submitted
28. Location of the sump proposal with co-ordinates and sump capacity shall be submitted.
29. Pumping capacity and arrangements for dewatering the sump shall be submitted.
30. Hydro geological study report, if any, shall be submitted.

#### **Others**

31. The location of the list of site services and its distance be submitted and also to be marked in the plans.
32. Deployment of surveyor as per statute is not mentioned in the employment potential.

#### **Plans and Sections:**

33. Conceptual plan shall be re-submitted showing conceptual size of the pit, afforestation, land use pattern at the end of this 5 year period and at the end of lease period.
