26(2)	Yearly report on PMCP setting forth the extent of protective and rehabilitative works carried out as per the approved Progressive Mine Closure Plan has not been submitted till date.
28	Notice of temporary discontinuance of work in mines has not been submitted in Form E when the mining or mineral processing operations in the mine or part thereof are discontinued for a period exceeding ninety days so as to reach within one hundred and twenty days from the date of such temporary discontinuance.
45(5)(c)	The holder of a mining lease shall submit online annual returns in respect of each mine to the Regional Controller of the Indian Bureau of Mines before the 1st day of July each year for the preceding financial year. Annual Return for the financial year 2020-21 has not been submitted so far.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
