महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection carried out by Sri. H.M.Shivakumar-Assistant Mining Engineer in presence of Sri. Y.Narayan Rao- Agent, Sri. Suresh Ganesh- Mining Engineer, & Shri. K.Rajagopalaiah Mines Manager on **04/10/2021**.

Rule	Nature of violations observed
11 (1)	<b>Modifications to approved RUMP along with PMCP</b> was approved vide letter No. 279/770/2003/BNG dated 18/02/2021 for the period from 2020-21 to 2024-25. The deviations observed in mining operations vis-a-vis approved document are given below:  It was proposed to Produce 8187 Tonnes of Magnesite Ore & achieve Development Quantity of 15204 CUM for the year 2020-2021. It is observed that the only 3655 Tonnes of Magnesite Ore is produced and 9185 CUM of development is achieved for the year 2020-21 thereby deviating to an extent of (-)70% & (-) 40% respectively from the approved proposals.
33	Surface plan, Geological Plans and Sections as per the Rule 32 of MCDR, 2017 are not submitted before 30 <sup>th</sup> June 2021 for the year 2020-2021.
