Srinivas, AMG in presence of Shri G. Pompapathi-Manager Mines, Shri. Shashidhara L- Mining Engineer & Shri Kummara Anil Kumar- Mine Geologist and other mining officials:

Rules	Nature of Violations observed
11 (1)	Mining Scheme was approved by IBM vide letter no. 279/372/93/BNG/982 dated 21/03/2016, for the period 2016-17 to 2020-21. The deviations observed in mining operation vis-à-vis approved document are given below.  It was observed that only 6000 Tones of overburden was handled against the proposal of
	35000 Tones, thus resulting in lowering of stripping ratio.
45(7)	The online Annual return for the year 2020-21 has been submitted by the Lessee;
	Following discrepancies are noted in the submitted copy as observed during site
	inspection.
	Part-I: The lease area (Surface area) utilization at the end of the year as given in Part-I (Sl
	No.12) has not been reported correctly in accordance with Para-8.6 (Financial Assurance)
	of the approved document. The total of the lease area utilization exceeds the granted ML
	area.
	Part -VII: In the cost of production table Royalty, DMF & NMET details have not been
	furnished to arrive at the cost of production.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
