বিষয/Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Karya Magnesite Mine (ML No. 2495) over an area of 86.25 Ha having mine code 39KAR14002 in Karya, Kurihundi and Chamanamadanahalli villages, Nanjangud Taluk, Mysore District, Karnataka state.

महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection carried out by Sri. H.M.Shivakumar-Assistant Mining Engineer in presence of Sri. R. Nirmal Kumar-Mining Engineer & Shri. R.Chandrashekar-Geologist on **05/10/2021**.

Rule	Nature of violations observed
	RUMP along with PMCP was approved vide letter No. 279/302/92/BNG dated 01/02/2018 for the period from 2018-19 to 2022-23. The deviations observed in mining operations vis-a-vis approved document are given below:
11 (1)	It was proposed to Produce 21455 Tonnes of Magnesite Ore & 321825 Tonnes of Dunite for the year 2020-2021. It is observed that the only 2406 Tonnes of Magnesite Ore & 72929 Tonnes of Dunite is produced for the year 2020-21 thereby achieving only 11% & 22% of the proposed production respectively and deviating from the approved proposals.
	There are no proposals for Mineral Stacks on Active dump 3 for the year 2020-21 & 2021-22. It is observed that huge quantities of mineral are stacked over this dump.
	It was observed that ground preparation is in progress for installation of Static Crushing and screening plant in North Eastern part of the lease area near ANFO mixing Shed. No such proposals are made in the approved Mining Plan for the year 2021-22.

33	Surface plan, Geological Plans and Sections as per the Rule 32 of MCDR, 2017 are not submitted before 30 <sup>th</sup> June 2021 for the year 2020-2021.
Rule 45(7)	As per part VII of the Annual Returns submitted for FY 2020-21, DMF, NMET & Royalty paid details have not been furnished and accounted for arriving at the cost of Production.

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- 03. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
