Sub: - Violation of the provisions of MCDR, 2017 in respect of your Umsoo Mootang Block-V mine (38MEG03015) over an area of 128.52 Ha. in Thangskai Village, Taluka- Narpuh, East Jaintia Hills district of Meghalaya state.

Sir,

On perusal of this office record, following provisions of MCDR 2017 have been found violated in your above mine –

| Rule No. | Nature of violation observed |

| 11(4) The holder of ML shall submit the mining plan to the competent authority for review at least 180 days before the expiry of 5 years period for which it was approved on the last occasion for mining operations for a period of 5 subsequent years. | The existing mining plan in respect of your aforesaid mine is valid up to 31.3.2021 & its next review is due for its submission. You have submitted the draft document but the same was dis-approved for reasons recorded in writing. The draft review of mining plan thereafter has not been received in this office. |

- 02 In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR 2017.
- 03 The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04 You are therefore advised to rectify the violation immediately and intimate the position to this office within a period of 45 (Forty Five) days from the date of issue of this letter.
