Violation of provisions of Mineral Conservation & Development Rules, 2017, in respect of your Adanakurichi & Alathiyur Limestone Mine over an area of 47.42 Ha in Adanakurichi & Alathiyur Village, Sendurai Taluk, Ariyalur District, Tamil Nadu.

Sir,

The following provisions of the MCDR, 2017 were found violated in your above mine during the inspection on 08/09/2022 by undersigned in presence of the mine official Shri G. Balu, AGM (Mines & Geology) & Shri K. Rathnivel, Mining Engineer:

Rule No.	Nature of Violation
11(1)	Mining operations have not been carried out as per the approved Modification to the Review of Mining Plan approved vide Letter No. TN/ALR/LST/ROMP/1606.MDS dated 10.11.2020 to the extent as mentioned below:
	a) There was a proposal to excavate 3,56,179 tonnes of ROM during the year 2021-22. However, only 1,76,659.38 tonnes of ROM have been excavated during the said period which is around 50% of the approved proposal.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development (Amendment) Rules, 2021.
- 03. The mining operation can be suspended under Rule 11(2), if the compliance of Rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
