Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017, in respect of your Adanakurichi Limestone Mine over an area of 17.58 Ha in Adanakurichi Village, Sendurai Taluk, Ariyalur District, Tamil Nadu.

Sir,

The following provisions of the MCDR, 2017 were found violated in your above mine during the inspection on 09/09/2022 by undersigned in presence of the mine officials Shri N. Jayabharata Reddy, GM(Mines), Shri G. Balu, AGM (Mines & Geology) & Shri K. Rathnival, Mining Engineer:

Rule No.	Nature of Violation
11(1)	<p>Mining operations have not been carried out as per the approved Modification to the Review of Mining Plan approved vide Letter No. TN/ALR/LST/ROMP/1573.MDS dated 11.09.2019 to the extent as mentioned below:</p> <p>a) <i>There was a proposal to excavate 2,37,406 tonnes of ROM during the year 2021-22. However, only 56,868.58 tonnes of ROM have been excavated during the said period which is less than 25% of the approved proposal.</i></p> <p>b) <i>There was a proposal to excavate 6,930 cubic metres of Overburden during the year 2021-22. However, only 140 tonnes of Overburden was excavated during the said period.</i></p>

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development (Amendment) Rules, 2021.

03. The mining operation can be suspended under Rule 11(2), if the compliance of Rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
