C I R C U L A R

02 posts of Chief Controller of Mines in pay Level-15 in the pay matrix (Rs.182200-224100) is vacant in Indian Bureau of Mines under the Ministry of Mines which is to be filled up by deputation (including short term contract).

02. Duties in brief of Chief Controller of Mines in IBM are as under:

Supervising and coordinating the work pertaining to the entire Mines Development and Regulation Division, Planning and Co-ordination Division and other divisions of IBM except ore dressing division. CCOM is responsible for the achievement of the target set for divisions. Guiding the officers of the division in technical and administrative aspects of their work. To issue directives for maintaining uniformity of approach, adoption of clear -cut objectives and monitor and supervise the work of all regional and zonal offices of MDR Division, and all other divisional and sub divisions offices at IBM head quarter including the training and skill development activities at HQ or other places. CCOM is also responsible for all statutory functions and duties as per MMDR ACT and rules made there under.

To assist the Controller General, IBM in the various technical and administrative matters and give advice on policy formulation, project implementation of various activities of the department in respect of Mineral Development and Regulation (MDR) Division and developmental function of Planning and Co-ordination (P&C) Divisions and other divisions of IBM other than Ore Dressing Division.

03. As per the Recruitment Rules to the post of Chief Controller of Mines, the candidates to be considered for appointment by deputation (including short term contract) should be Officers of the Central Government or the State Government or Union territory administration or public sector undertakings or Universities or recognised research institutions or autonomous bodies or statutory organizations :-

(A) (i) holding analogous post on a regular basis in the parent cadre or Department; or

(ii) with three years service in the grade rendered after appointment thereto on a regular basis in posts in Level 14 in the pay matrix (Rs. 144200-218200) or equivalent in the parent cadre or Department, and

(B) Possessing the following educational qualifications and experience;

- (1) (i) Bachelor of Engineering or Technology in Mining Engineering from a recognised University or institution
(ii) 18 years experience in core Mining activity in:-
(a) Managerial position in Metalliferous (Non-coal) mines which includes the period as graduate or management or junior trainee engineer; or
(b) Government Department dealing with mines and minerals, as Group 'A' officer dealing with mines and minerals; or
(2)(i) Master of Engineering or Technology in Mining Engineering from a recognised University or institution;
(ii) 16 years experience in core Mining activity in:-
(a) Managerial position in Metalliferous (Non-Coal) mines which includes the period as graduate or management or junior trainee engineer; or
(b) Government Department dealing with mines and minerals, as Group 'A' officer dealing with mines and minerals.

Note 1. The departmental officers in the feeder grade who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2. The period of deputation including short term contract in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of Central Government shall ordinarily not exceed five years.

Note 3. The maximum age-limit for appointment by deputation including short term contract shall be not exceeding fifty-eight years as on the closing date of receipt of applications.

04. The deputation period will be initially for 03 years and will be considered for further extension on the basis of requirement of this department and NOC from the parent department. However, the officer may also consider for pre-mature reversion to the parent cadre by serving 03 months advance notice to the parent department as well as to the officer in terms of provisions contained under DOPT OM No. 6/8/2009-Estt.(Pay II) dated 17-06-2010.

05. Application containing the bio-data (in triplicate) of the officer who fulfills the above as on the closing date may be sent through proper channel addressed to **the Controller of Mines (P&C), 2nd Floor, Indian Bureau of Mines, Indira Bhavan, Civil Lines, Nagpur - 440 001** in the enclosed bio-data proforma (Annexure - I) within 60 days from the date of publication of advertisement in the Employment News alongwith up-to-date Confidential Reports/Dossiers for the preceding 5 years, Integrity Certificate, Vigilance Clearance and No penalty certificate for preceding 10 years of the officer concerned. Applications received after the closing date will not be entertained. Also, advance copies of application or not accompanied with all above certificates/enclosures are liable to be rejected.
