Sub: Violation of provisions of MCDR, 2017 in respect of your "Ghatkuri" Iron Ore Mine over an area of 138.848 Hectare in West Singhbhum district, Jharkhand State.

Sir,

On Scrutiny of Returns & Office Records Rule 45 (7) of Mineral Conservation and Development Rules, 2017 were found violated in your above mine. Which is explained as below:-

As per Your monthly returns filed online for the period from March 2018 to July 2018 Domestic Sale has been reported in Nature of Dispatch instead of Domestic Transfer and Sale Value has been reported for the Consignee "Rungta Mines Ltd." (Chaliama Steel Plant) situated at Dist – Seraikela Kharsawan, Jharkhand with Consigner "Rungta Mines Ltd.", Rungta House, Chaibasa – 833201, Jharkhand (Ref:- Stock Transfer Memo received at this office from your end) which is not as per Explanation Mentioned under Rule 45 (8) (III) of MCDR 2017 which clearly states that "where sale has occurred, between related parties and is not on arms' length basis, then such sale shall not be recognized as a sale for the purposes of this rule and in such case, sub-clause (IV) shall be applicable" and Sub clause (IV) says about "where the sale has not occurred, the average sale price published monthly by the Indian Bureau of Mines for that mineral grade or concentrate for a particular State shall be referred"

The above aforementioned description clearly shows that wrong or false information has been supplied in your monthly return which clearly attracts violation of Rule 45 (7) of MCDR 2017.

02. You are, therefore, advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
