Sub:-Violation of provisions of Mineral Conservation & Development Rules, 1988 in respect of Naganpur Limestone Mine (ML.No.2357) over an area of 4.43 Ha situated in Naganpur- village Tq-Mudhol, District Bagalkot of Karnataka State.

Sir,

The following provision of Mineral Conservation & Development Rules, 1988 were found violated during the inspection of your above mine on 24/8/2016 AN by the undersigned.

Rule No.	Nature of violation observed
13(1)	The mining operations are not carried out as per approved scheme of mining on 10.9.2012 to the extent indicated below. Excavation (a) The mining operations have been carried out in lower benches (II-Bench) in NW side, with in lease & NE has been made high wall single bench, which was not proposed in approved scheme of mining. (b) The overburden waste material dumped outside the lease area near crushing & powder unit adjacent of lease & NW side road work, where no proposal was there. © The mine machinery is being used for working in mine but method of mining is proposed as manual method.
45(5)(b)	An annual return for the year 2014-15 which shall be submitted before the 1 st July of the preceding financial year in the prescribed form but you have ^{not} submitted the annual return to this office till. Therefore, you are directed to submit aforesaid return either in hard copy and/or online system immediately through www.ibm.gov.in/index.php/auth/login .
42(1)(c)(i)	A full time Mining Engineer and Geologist have not been employed for the purpose of carrying out mining operations in accordance with these rules.
63	A Self-Appraisal Report to be submitted by owner of the mine under Rule 63 of MCDR, 1988 stating extent of implementation of Approved Mining Plan/Scheme of Mining during the year of 2015-16 along with supporting plans/sections, representative photographs in hard as well as soft copy has not been received in this office.
23(E)(2)	A yearly report before 1 st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted to this office.

In this connection, it is again brought to your notice that the above violation constitutes an offence punishable under Rule 58 of MCDR 1988.
