The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the Review of Mining inspection on 13.10.2022 in the presence of Sri.A. Aneel Kumar, Mine Manager&Sri. Veera Raghavulu, Geologist& Qualified Person.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017.Further, inability to comply the provision of Rule 11(1) is liable for suspension of mining operations under 11(2) of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
