Sub: Violation of provisions of MCDR, 2017 in respect of your Raikela Iron Mine over an area of 45.932 hectare in Sundergarh district of Odisha.

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above said mine during inspection on 07.10.2017 by the undersigned accompanied by S/Shri Rajendra Prasad Khuntiya, Senior Inspector, (Koira Circle) Kailash Kumar Pradhan, Mine Manager, N Patel, DGM (Mines) and B N Mohanty, Manager (Geology) of your mine.

54 (b)	Holder of mining lease shall maintain the sub grade or mineral reject stack register along with grade.	During inspection it is observed that sub-grade or mineral reject stack register along with not maintained.
55 (3)	Holder of mining lease shall employ a whole- time mining engineer having prescribed qualification and experience under these rules in case of Category – 'A' mines.	During inspection it is reported that whole-time mining engineer is not appointed having qualification and experience prescribed under these rules.

**02.** It is brought to your notice that these violations constitute an offence punishable under Rule 62 of MCDR, 2017.

Besides, inability to comply with the provision of Rule 11 (1) is liable for suspension of mining operations according to the provisions of Rule 11 (2) of MCDR, 2017.
