Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of Lawa Gold Mine, over an extent of 54.55 hectares situated in Lawa Village, Nimdih Taluk, Saraikela Kharswan District, Jharkhand State - Reg.

Sir,

The following provision of the Mineral Conservation and Development Rules, 2017 was found violated in your above mine during the inspection on 07/10/2021 by the undersigned.

FOR CT	<ul> <li>148m drive at 226m RL (approx. 88m beyond 740E &amp; 60m above 900N); whereas during inspection no such drive was existing in the Bhalukad Block.</li> <li>b) It was observed that the roof &amp; side walls of the existing drives were highly disturbed at many places. Huge sludge of debris was found to be accumulated in the drives running down from the raises connected to the old surface workings (in tandem) in the Bhalukad Block. There is no proper access to the adit at 1<sup>st</sup> level itself.</li> </ul>
	<ul> <li>c) It is proposed in page-84 to provide ventilation in Bhalukad Block upto lower level, whereas during inspection it was observed that the fan was not working and overall the ventilation was found to be very grim at 1<sup>st</sup> &amp; 2<sup>nd</sup> level itself.</li> <li>d) There was no proposal to drive the bypass North x-cut in 2<sup>nd</sup> level between 680E to 720E whereas such workings were carried out in Bhalukad Block, without any approved modification to the mining plan.</li> </ul>
	e) It was proposed in page-73 & Plate-11-B to drive 26m raise whereas no such raise was made and approx 240m of drive was made towards east of 400E (between 920N to 940N); which is not as per the existing proposal for 2020-21 for Tamapahar Block and without any approved modification to the mining plan.
	f) The entire drives developed again of approx 250m in the Lalkhadan block is not as per the existing proposal for 2020-21 and without any approved modification to the mining plan.
	g) It was proposed in page-44 to drill 6 nos of boreholes during 2020-2021, whereas only 3 boreholes has drilled as per the details submitted in Form-I.
	h) It was proposed to stope out some areas between 1-B to B-2 & B-2 to 2A levels in the Bhalukad block; whereas proposal for commencing such activity was neither received nor carried out.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under Rule 11(2) if compliance of rule is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
