

SCRUTINY ON DRAFT FINAL MINE CLOSURE PLAN IN RESPECT OF SURJABASA LIMESTONE MINE (16.70 HA) IN VILLAGE SURJABASA, DISTRICT SINGHBHUM WEST, STATE JHARKHAND OF M/S NARSINH HARJI SUBMITTED UNDER RULE- 24 OF MINERAL CONSERVATION AND DEVELOPMENT RULES,2017.

- 01. Cover page:** Mineral Conservation and Development Rules may be written correctly.
- 02. Item no. 1.2.10:** Nearest railway station and approximate distance may be mentioned.
- 03. Item no. 1.3:** Date & reference of modification in review of mining plan approved on 14/02/2019 may be mentioned and a copy of approval letter may also be enclosed in the annexure.
- 04. Item no. 1.4:** The modification in review of mining plan approved on 14/02/2019. Hence 'As per modification in approved review of MP' may be mentioned instead of 'As per submitted modification in approved review of MP' and information may be furnished as per modification in approved review of MP for all the items.
- 05. Item no. 1.4.21:** Actual work done not mentioned.
- 06. Item no. 1.4.28:** Area proposed to be put to use in last approved document (Modification in approved review of mining plan approved on 14/02/2019) may be given.
- 07. Item no. 2.3:** Date of balance reserve as on 01/04/2018 may be corrected as 01/04/2019.
- 08. Item no. 5.1.1:** Area for total degraded land and excavated area may be corrected.
- 09. Item no. 5.1.1(c):** Due to non-operational status of the mine, there is no change of land degraded by mining and allied activity up to the end of the year 2018-19. Hence land use pattern at the end of 2018-19 may be corrected.
- 10. Item no. 5.1.2:** The para may be written clearly.
- 11. Item no. 5.1.12:** The para may be written clearly explaining the disposal of mining machinery.
- 12. Item no. 5.2:** Proposals for reclamation & rehabilitation could not be implemented by the lessee during the year 2018-19 due to non-operational status of the mine. Hence proposal on protective measures for reclamation & rehabilitation works should be given for the year 2019-20 only.

01. Geological Plan Sections: (Plate no. 5 & 6):

Proposals made for exploration in the last mining plan approved on 29/11/2017 and modification in review of mining plan approved on 14/02/2019 could not be carried out due to non-operational status of the mine up to 2018-19. Hence borehole proposals for exploration may be shown during the year 2019-20 instead of 2018-19.

02. Final mine closure plan: (Plate no. 7), Reclamation plan & sections: (Plate no. 8) & Financial Assurance plan: (Plate no. 11):

There was no backfilling and plantation up to 2018-19 as proposed in the last approved document. Hence backfilling and plantation proposal may be shown for the year 2019-20 only. Necessary corrections may be made accordingly.
