Sub: Violation of provisions of MCDR, 1988 in respect of Gudimalkapur Limestone mine over an area of 4.75 ha in Gudimalkapur village, Mellacheruvu Mandal & Nalgonda District, Telangana State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection on 10.02.2016 by undersigned in the presence of Sri V.Ramachandram, Asst.General Manager(Mines).

Rule No.	Nature of Violation
13(1)	Mining operations should have been undertaken in accordance with the approved Mining Plan/Scheme of mining. The Scheme of Mining was approved vide no. AP/NLG/MP/Lst-3/Hyd on 20.1.2015 for the period 2013-14 and 2017-18 and following deviations observed during the inspection. 1. In Para 4,table-6 , Two(02 nos) core boreholes of 30 meter depth each has been proposed for the year 2014-15 but the core drilling was still not started and neither information for starting of drilling received by this office. 2. In Para 9, 180saplings for the year 2014-15 has been proposed but no plantation done in the lease area.
23 E(2)	The owner .agent, manager or mining engineer shall submit to the Regional Controller of Mines, a yearly report before 1 st July of every year setting forth extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation ,reasons thereof. But the same not submitted in this office for 2014-15.
42	Every holder of Category 'A' Mine shall employ a whole time Mining Engineer and a Geologist. However you have not employed Mining Engineer & Geologist.

02. In this connection, it is brought to your notice that the above said violations constitute an offence punishable under Rule-58 of MCDR, 1988. Besides, inability to comply the provision of Rules 13(1) is also liable for suspension of mining operations under the provision of Rule 13(2) of MCDR, 1988.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
