Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 22.10.2021 by the undersigned along with Shri K. Srinivas, AMG in presence of Sri Shanmukhappa Mandal, Agent & Shri Satish Chowgule, Geologist, and other mine officials.

Rules	Nature of Violations observed
26(2)	Yearly report on PMCP setting forth the extent of protective and rehabilitative works carried out as per the approved Progressive Mine Closure Plan has not been submitted till date.
28	Notice of temporary discontinuance of work in mines has not been submitted in Form E when the mining or mineral processing operations in the mine or part thereof are discontinued for a period exceeding ninety days so as to reach within one hundred and twenty days from the date of such temporary discontinuance.
45(7)	Following discrepancies were observed in the Annual return submitted for FY 2020-21, (i) In Part VI (Production, Dispatch and Stock), Ex-Mine price have been furnished for lumps & Fines although the mine is non working & no sale/dispatch of ore had taken.

	(ii) In Part VII (Cost of Production), Production proposal for the financial year 2020-21 is mentioned as zero against the proposal of 4,60,000 Tons.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
04. You are advised to rectify the above violations immediately and intimate the position to this office **within 45 (Forty-Five) days** from the date of issue of this letter.
