विषय – म0प्र0 राज्य के Jabalpur जिले में स्थित आपकी Dhamki Iron Ore Mine (क्षेत्रफल 6.88 हे0) में खनिज संरक्षण एवं विकास नियमावली, 2017 के नियमों का उल्लंघन।

महोदय,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during the inspection by the undersigned on 26.04.2019 in presence of owner's representative Shri. Vinai Jha and Shri Sandeepan Sarkar (QP):

नियम/धारा उल्लंघन के प्रकार का विस्तृत ब्यौरा

**नियम 11(1)**— No holder of a mining lease shall commence or carry out mining operation in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Govt.

The Scheme of Mining of above mentioned mine was approved vide letter No.-MP/Jabalpur/Iron Ore/M.Sch.89/2013-14 dated 8/5/2014 with proposals from 2014-15 to 2018-19. During inspection following deviations from approved proposals were observed:

(i) In approved Scheme of Mining, it was proposed to drill 3 core boreholes in 2014-15 however, no boreholes were drilled within stipulated time frame and till the date of inspection. Thus mining operations are being not carried out in accordance with the proposals given in the approved Scheme of Mining.

**नियम 55**— (1) For the purpose of carrying out reconnaissance, prospecting or mining operations in accordance with these rules,—

3. every holder of a mining lease shall employ, in case of—

(i) category 'A' mines, a whole-time mining engineer and a geologist;

(ii) category 'B' mines, a part-time mining engineer and a part-time geologist:


As per this office records your above mentioned mine is 'A' category mine, but a whole-time geologist is not appointed in your above mentioned mine.

02 In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.

03 The mining operations can be suspended under rule 11(2) of MCDR-2017 if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.

04 You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.


