विषय - म0प्र0 राज्य के Balaghat जिले में स्थित आपकी Selwa Manganese Mine (क्षेत्रफल 4.906 हे0) में खनिज संरक्षण एवं विकास नियमावली, 2017 के नियमों का उल्लंघन।

महोदय,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during the inspection by the undersigned on 2.05.2019 in presence of Shri. Sandesh Jain (Managing Partner), Shri A.K. Thakur (QP), and Shri Amit Mishra (Geologist):

नियम/धारा उल्लंघन के प्रकार का विस्तृत ब्यौरा

नियम 11(1)- No holder of a mining lease shall commence or carry out mining operation in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Govt.

The Scheme of Mining of above mentioned mine was approved vide letter No.-BGT/MN/MPLN-1017/NGP dated 16/3/2015 with working proposals valid from 2014-15 to 2019-20. Period of approved Scheme of Mining has already been expired on 31/3/2019 but, mining operations were continued inside the mine without a valid document. Thus there is violation of Rule 11(1) of MCDR'2017.

Non compliance of the rule 11(1) of MCDR-2017 may lead to suspension of Mining operations under rule 11(2) of MCDR-2017.

02 In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.

03 You are, therefore, directed to **show-cause** within a period of **30 days** from the date of issue of this letter, as to why mining operations in your above mine should not be suspended in accordance to rule 11(2) of MCDR, 2017.

04. Please note that no further notice will be given to you in this regard.
