विषय - म0प्र0 राज्य के Satna जिले में स्थित आपकी Bhatia Limestone Mine (क्षेत्रफल 9.008 हे0) में खनिज संरक्षण एवं विकास नियमावली, 2017 के नियमों का उल्लंघन।

महोदय,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during the inspection by the undersigned on 7.05.2019:

नियम/धारा उल्लंघन के प्रकार का विस्तृत ब्यौरा

नियम 11(1)— No holder of a mining lease shall commence or carry out mining operation in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Govt.

The Scheme of Mining of above mentioned mine was approved vide letter No.-MP/Satna/Limestone/M.Sch-66/ 13-14 dated 9/7/2014 with working proposals from 2014-15 to 2018-19. Following deviations from approved proposals in respect of 2018-19 were observed during inspection:

- (i) It was proposed to advance working faces towards south with vertical development upto 328 mri however, production and development not done in accordance with approved proposal and pit was extended laterally in eastern direction.
- (ii) Simultaneous backfilling was proposed however no backfilling was done in 2018-19 as pit could not be developed upto proposed depth. Generated OB are stacked inside pit for which there was no proposal in the approved Scheme of Mining.


Thus mining operations were not carried out in accordance with the proposals given in the approved Mining Plan.

02 In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.

03 The mining operations can be suspended under rule 11(2) of MCDR-2017 if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.

04 You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
