विषय – म0प्र0 राज्य के Katni जिले में स्थित आपकी Salaiya Paharahi Limestone Mine (क्षेत्रफल 4.69 हे0) में खनिज संरक्षण एवं विकास नियमावली, 2017 के नियमों का उल्लंघन।

महोदय,

The following provisions of the Mineral Conservation and Development Rules, 2017, were found violated in your above mentioned mine during the inspection by the undersigned on 8.05.2019:

नियम/धारा उल्लंघन के प्रकार का विस्तृत ब्यौरा

नियम 11(1)– No holder of a mining lease shall commence or carry out mining operation in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Govt.

The Mining Plan of above mentioned mine was approved vide letter No.-MP/Katni/Limestone/M.PLN/R-15/2012-13 dated 28/8/2013 with working proposals from 2014-15 to 2018-19. During inspection following deviations from approved proposals were observed:

(i) It was proposed to develop and merge quarry 1 and quarry 3 during plan period and there was no proposal for working in quarry 2. However, quarry 1 and quarry 3 could not be merged as proposed in the approved mining plan. Besides, quarry 2 has also been deepened for which there was no proposal in approved mining plan. Thus mining operations were not carried out in accordance with the proposals given in the approved Mining Plan.

नियम 55– (1) For the purpose of carrying out reconnaissance, prospecting or mining operations in accordance with these rules,—

3. every holder of a mining lease shall employ, in case of—

(i) category 'A' mines, a whole-time mining engineer and a geologist;

(ii) category 'B' mines, a part-time mining engineer and a part-time geologist:


As per this office records your above mentioned mine is 'A' category mine, but a whole-time geologist is not appointed in your above mentioned mine.

02 In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.

03 The mining operations can be suspended under rule 11(2) of MCDR-2017 if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.

04 You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
