The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above said mine during inspection on 18.10.2017 by the undersigned accompanied by S/Shri K & Sarda, Power of Attorney Holder, Dr G S Jaiswal, Geologist, P K Kunar, Foreman of your mine.

11 (1)	As per the approved mining scheme dated 25/08/2014. i) There was no proposal to stack the produced ROM from mine in the northern side of quarry between grid 100N-200N. ii) It was proposed to do plantation of 1187 plants over dump and safety zone area.	i) During inspection it is observed that ROM stack is scattered over the place in northern side of quarry between grid location 100N-200N. ii) During inspection it is reported that only 400 plants were planted.

45 (5) (c) (i)	Annual Return which shall be submitted before the 1st July each year for the preceding financial year.	No annual returns have been received till date to this office within the specified date i.e. by the I st July of respective succeeding years.
55 (3)	Holder of mining lease shall employ a part- time mining engineer having prescribed qualification and experience under these rules in case of Category - 'B' mines.	During inspection it is reported that Part-time mining engineer is not appointed having qualification and experience prescribed under these rules.

02. It is brought to your notice that these violations constitute an offence punishable under Rule 62 of MCDR, 2017.

Besides, inability to comply with the provision of Rule 11 (1) is fiable for suspension of mining operations according to the provisions of Rule 11 (2) of MCDR, 2017

Further in view of the above position, the information furtished under Rule 15(5) in the Annual return is construed as furnishing wrong or false information, which leads this office to advise the state government torder rule 15 () to -

- (i) Order suspension of all mining operations in the mine and to revoke the order of suspension only after ensuring proper compliance,
- ii) Take action to imitate prosecution under these rules:
- this Recommend termination of the mining lease, in case such suppression or misrepresentation of information indicates abetiment or contivance of illegal mining:
- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
