Chapter- II(Geology and Exploration)

- 1. The Geological Study Report in terms of Rule 12(4A) of MCDR(Amended), 2018 has not yet been submitted. The violation letter has been issued to the lessee to submit the geological study report.
- 2. All the details should be in concurrence with approved scheme of mining and Geological Study Report in terms of Rule 12(4A) of MCDR (Amended) Rules, 2018.
- 3. Details of the said geological report may be furnished in this chapter.

Chapter-III (Mining)

- 1. The details should be in concurrence with the approved Scheme of Mining approved on 28.9.2015.
- 2. There is a deviation in the proposals of FMCP document from the approved proposals of Scheme of Mining for the years 2018-19 and 2019-20 of closure period.

Chapter- IV (Stacking of Top Soil, Mineral Rejects, Fines)

- 1. Para 4.1: The details of old dumps and stacks are not matching with that of approved scheme of mining, as there was no operation of mine for the last three years.
- 2. Para 4.2: The details of generation of waste during the closure period of two years is not tallying with that of approved scheme of mining.
- 3. Para 4.3: The quantity of waste for the closure period of two years may be given as per the approved scheme of mining.

Chapter-V (Final Mine Closure Plan)

- 1. Para 5.1: Details may be given as per the approved scheme of mining regarding the degraded area.
- 2. Para 5.1.2: The lessee should propose to erect fencing of excavated pits to prevent fall of persons/ cattles etc.
- 3. Para 5.1.3: The existing afforestation details may also be furnished.
- 4. Para 5.3: Financial Assurance: The table for calculation of F.A may be furnished as per the approved Scheme of mining.
- 5. Para 5.4: Financial assurance of the area considered for calculation in the last approved scheme of mining as per new rates under MCDR, 2017 may be furnished.
