Clarification may be given.
- 24. Plate no.8 (Financial assurance Plan): The F.A table should be incorporated as per para 8.6 of text part. Detailed breakup of the area to be marked on the plate with different colour.

- 25. Plate No.9 (Environmental Plan): The Environmental Plan may be drawn on 1:2000 scale
- 26. Plate No. 10(Reclamation Plan): (i) proposed environmental monitoring station at core-zone should be properly reflected. (ii) Proposed year-wise afforestation and other environmental protection measures should properly highlighted in the plan as per R & R approved.(iii) Tabular column may be inserted of the R & R measures shown year wise.
- 27. A separate plate showing the dump sections may also be given.
