Subject: Violation of provisions of MCDR, 2017, in respect of your Larung Limestone Mine (38MEG03012) over an area of 4.76 Ha. in Wahiajer Village, PO - Elaka Narpuh, East Jaintia Hills district of Meghalaya State.

Sir,

On perusal of office record, the following provision of MCDR, 2017 has been found violated in your above mine.

Rule Number	Nature of violations observed
45(5): The holder of a mining lease shall submit online return in respect of each mine to the Regional Controller or any other authorized official of Indian Bureau of Mines in the following manner, namely: (c) An annual return which shall be submitted before the 1 <sup>st</sup> day of July each year for the preceding financial year in electronic form, along with a signed print copy of the same if it is not digitally signed, in the respective form.	Following discrepancies are observed in your submitted online annual return in form H-8 for the year 2019-20 vis-a vis submitted monthly returns in form F-8 during 2019-20. <ul style="list-style-type: none"><li>• Production figure furnished in annual return is not matching with the cumulative production figure of monthly returns.</li><li>• Number of days mine worked (Part-II) furnished in annual return is not matching with the cumulative figure of monthly returns.</li><li>• Interest &amp; depreciation in Part-II A have been reported, where as in cost of production section (Part-VII), same have been reported zero.</li><li>• Resource/reserve figures furnished under Part-V is not matching with previous submitted annual return.</li></ul>

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR 2017.
03. If the above rules are not complied; The Regional Controller of Mines may advise to State Government to take following action under rule 45(7)(a):
  - (i) Order suspension of all mining operations in the mine and to revoke the order of suspension only after ensuring proper compliance;
  - (ii) Take action to initiate prosecution under these rules;
  - (iii) Recommend termination of the mining lease, in case such suppression or misrepresentation of information indicates abetment or connivance of illegal mining;
04. You are advised to rectify the violation immediately and intimate the position to this office within a period of 45 (Forty five) days from the date of issue of this letter.
