With reference to your letter cited above on the subject, the inspection of the mine was carried out by Shri S.K.Muduli, JMG along with Sri P,V.R.S Raju-QP, Sri K.Srinivasa Rao-Agent, Sri A.Nagarajesh-Geologist, Sri G.Naresh Kumar, Sri M. Appala Raju- Manager (Mines) on 25.10.2019 and found certain deficiencies which were forwarded to you and your Qualified Person on respective e.mail ids i.e., corp@myhomegroup.in, pvrsraju@myhomegroup.in, mines@myhomegroup.in and nareshkumar.g@myhomegroup.in

02. You are advised to attend the deficiencies as per the annexure and resubmit the document, complete in all respects, in three bound copies along with soft copy in the form of CD (2Nos.). In this regard you are directed to submit the Financial Assurance in the form of Bank Guarantee for the area put on use for Mining and allied activities @ RsThree lakhs/hectare for category 'A' mines provided that the minimum amount shall be Rs. Ten lakhs as per the provision of Rule 27(1) of MCDR, 2017 at the time of submission of final copies of the document within 15 (fifteen) days from the date of issue of this letter, failing which the document will be disposed without giving any further opportunity.

03. The para-wise clarification & the manner in which the deficiencies are attended should be given while forwarding modified document.

Scrutiny comments of Modified Mining Plan for Choutapally Limestone Mine -II over an extent of 156.586 Ha in Choutapally & Mellacheruv Village, Mellacheruv & Matampally Mandal, Suryapet District of My Home Industries Private Limited, DOI-25.10.2019.

General

- 1) Plan period and proposal Period to be submitted separately.
- 2) The clinker plant capacity, the proposed clinker plant expansion and each mine wise limestone feeding requirement has not been discussed in specific manner.
- 3) Status of EC and CFO to be submitted at the introduction.
- 4) The reason for modification needs to be justified properly highlighting all the reasons in respect of subgrade generation, reduction in ROM production, change in location of mining, change in exploration proposal.
- 5) Review of PMCP work, afforestation, location of mine development, sub grade generation and its dumping/utilization. Status of compliance of violation to be submitted. Review of production to be submitted correctly. Justification to be submitted for deviation.

Geology

- 6) The lithology of Geological plan and section should be marked correctly correlating the geologically mapping and bore hole lithologs.
- 7) Brief description of the purple argillaceous limestone and purple shale to be submitted separately.
- 8) Details of prospecting operation carried out during the PL period and exploration carried out during ML period need to be submitted separately. Details of exploratory bore holes needs to be submitted in tabular form along with summarized BH lithology.
- 9) The Ground Control Points (GCP) to be demarcated in the surface plan. BM to be established within the ML and its level and co-ordinates to be submitted in plan and text.
- 10) Proposed drilling BHs co-ordinates to be submitted in WGS 84 & UTM format.
- 11) Modification in approved exploration proposal for the year 2019-20 needs to be justified properly.
- 12) Pit slope, cut off grade and recovery factor not mentioned in the reserves/resources estimation parameter.
- 13) Estimate reserves/resources between the cut off grade and threshold value.
- 14) UNFC code wise resources/reserves grade to be submitted.

Mining

- 15) Dimension of the existing pit and location co-ordinates to be submitted.
- 16) Bench parameters and blast hole drilling parameters to be submitted
- 17) Drawing in respect of layout of blasting pattern to be submitted in text instead of as a separate plate.
- 18) Location details of explosive magazine ANFO mixing should be submitted in the text.
- 19) Reason for reducing the ROM production needs to be elaborated.
- 20) The bench wise weighted average grade of proposed mining block for each year needs to be furnished and the mechanism for the grade control for optimum utilization of mineral along with blending techniques needs to be furnished. Bench parameters needs to be mentioned in the text.
- 21) In the Conceptual stage, Reclaimation by utilizing Siliceous Limestone is not allowed hence such proposal to be avoided. Green belt development proposal needs to be submitted along the nala barrier zone in western part of the lease.
- 22) Proposal for blending/utilization/stacking of sub grade mineral needs to be submitted.

Stacking and utilization of top soil, mineral reject and waste

- 23) Locations of top soil reuse/spreading needs to be submitted and demarcated in the year wise production and development plan. The location co-ordinates of mineral reject stack to be submitted. The top soil bench needs to be demarcated in the Year wise production and development plan.
- 24) Manner of disposal of high siliceous limestone to be submitted. In case of dumping configuration, sequence of year wise build up of dumps and proposals for protective measures to be submitted.

PMCP

- 25) Information in respect of mined out land to be submitted correctly.
- 26) Reduction in the afforestation proposal needs to be justified properly. Proposal to carry out environmental monitoring needs to be submitted.

Plans and Section

27) 5 Year wise mining block upto the end of lease period to be demarcated in the Conceptual Plan and Conceptual section to be prepared and submitted.
