Sub: Violation of Provisions of Mineral Conservation and Development Rules,2017 (MCDR),2017 in respect of Swarna Akkamma Limestone Mine of Smt. Swarna Akkamma over an extent of 74.78 ha in Piduguralla village & Mandal, Guntur Dist, Andhra Pradesh.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated during the Mining Plan inspection of the above mine on 10.10.2017 by Smt. Ch. Suseela, Asstt. Mining Geologist of this office accompanied by Sri. S.R. Kumara Swamy, Qualified Person and Sri.S. Subramanyam, Lessee,s Son.

Rule No.	Nature of Violation
11(1)	The following mining operations were not carried out in accordance with the document approved vide this office Lr.No.AP/GNR/MP/Lst-20/Hyd dated 10.12.2014 to the extent indicated below: It was proposed to dig 55 trial pits during the last scheme period i.e., from 2014-15 to 2016-17; against which only 20 trial pits were reported to be dug. The remaining 35 trial Pits have not been made.
12(5)	The sampling of drill cores or chips, pit samples and trench samples shall be done for the entire mineralized portion at regular intervals, preferably meter wise or less, and chemical analysis for the major radical shall be done for all the samples. The chemical analysis of the samples collected from 20 trial pits have not been made available during inspection.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of Mineral Conservation and Development Rules, 2017. Inability to comply the provision of Rule 11(1) is also liable for suspension of mining operations under rule 11(2) of MCDR, 2017.

03. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
