Sub: Violation of provisions of MCDR, 2017 in respect of your Asurabanda Chromite Mines, over an area of 91.827 hectare in Dhenkanal district of Odisha State

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above said mine during inspection on 27.10.2018 by the undersigned along with Shri Dilip Jain, JMG accompanied by S/Shri Abhishek Rath , Agent, Satyabadi Sahu, Mine Manager of your mine.


Rule No.	Proposed in the approved mining plan / Rule	Violation
11 (1)	As per the approved mining scheme dated 05/11/2008. i) It is proposed to do exploration by drilling 54 nos of bore holes during the year 2017-18. ii) It is proposed to generate 38008 cu.m. of waste material with production of 150030 tonnes of ROM during the year 2017-18. iii) It is proposed to do construction of retaining wall of 550 m in length. afforestation on dumps by planting 160 nos of saplings and 800 nos in barren area during the year 2017-18	i) During inspection it is observed that drilling of 9 nos of boreholes only were carried out. ii) During inspection it is observed that 2342 cu.m. of waste was generated by producing 3665 tonnes of ROM which is against the proposal. iii) During inspection it is observed that retaining wall and afforestation not carried out as proposed.
26 (2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof.	A yearly report for the year 2017-18 as per the format specified by the Indian Bureau of Mines, setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan has not been submitted till date to this office.

02. It is brought to your notice that these violations constitute an offence punishable under Rule 62 of MCDR, 2017.

Besides, inability to comply with the provision of Rule 11 (1) is liable for suspension of mining operations according to the provisions of Rule 11 (2) of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within **45 (forty-five) days** from the date of issue of this letter.
