Sub : Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Girgaon Bauxite Mine,(Mine Code 07MSH13008 Area-140.20Ha, M/s Bhartesh Construction Company situated in Girgaon Village, Shahuwadi Taluka,Kolhapur- District of Maharashtra State.

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 02/11/2018 by the undersigned in presence of Mr. G.R.Nagraj, Mines Manager and Mining Engineer,Shri Girish Patil, Geologist.

Rule	Nature of Violation observed
11(1)	Mining Operation have not been carried out in accordance with the Scheme of Mining(SOM) approved vide letter no. MSH/Mech-90(MAH)/Goa/2014-15, dated 20.4.2015 to the extent indicated/para:- In natural course of seasonal nalla passing through the ML area,fines observed stacked without such approval in the SOM. The above said violation was pointed out previously by this office. During inspection it has observed that the stacked material were not fully shifted.
45(7)(a)	It has been observed in the annual returns 2017-18, that the:- (i) Part V sec 3:- The Reserve and resource estimated at the end of the year was not updated.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
