## महोदय/Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 04.02.2020 by undersigned in presence of Shri Basavraj Patil, mine supervisor:

Rules	Nature of Violations observed
11(1)	As per the approved Scheme of Mining, approved by IBM vide letter no. MSH/MAN-282(KNT)/GOA/2013-14 dated 01/08/2014, for the period of 2014-15 to 2018-19: It is proposed to maintain height of working benches at 3m, but during the course of inspection it was found that, at places, height of the working benches were maintained at 5 to 6m.
11(4)	No Review of Mining Plan was found submitted by this lessee to this office for approval for the proposal period from 2019-20 to 2023-24.
28(1)	During the course of inspection it was understood that the mine was not working for at least last 3 months; but notice of temporary discontinuance in Form –E was not submitted by the lessee to this office.
33	The plans and sections for the year 2019-20 have not found either prepared or submitted on or before 31st June, 2019.
35(2)	Online self-assessment report of star rating for the F.Y. 2018-19 in the format prescribed by the Indian Bureau of Mines was not found submitted by the lessee as on the date of inspection.

45(5)(c)(i)	Annual Return for the F.Y. 2018-19 which shall be submitted on or before 1 <sup>st</sup> day of July, 2019 was not found submitted to the Regional Controller of Mines, Goa by the lessee as on the date of inspection.
55(1)(3)(iv)	No part-time Mining Engineer and part-time Geologist were found appointed in the mine as on the date of inspection.

- 02. It is brought to your notice that violation of the above Rule constitutes an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within **45 (Forty Five) days** from the date of issue of this letter.
