The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 06/10/2020 by the undersigned in presence of your representativeShri Raju M. Bora and shri B.S. Varma, Mine Manager.

35(2)	Every holder of a mining lease shall monitor his mining and allied activities as per notified template of star rating in the format prescribed in this behalf by the Indian Bureau of Mines and shall submit online in self assessment report before
	the 1 <sup>st</sup> day of July each year for the previous financial year. However, the same has not been submitted so far for the year 2019-20
45(7)	During the year 2019-20, 14000 Tonnes of ROM production from the mine head were reported. However, as per the Annual Return 2019-20, the Lease area (surface area) utilization as at the end of year(hectare) are observed as same(no change) with respect to the previous year (2018-19).

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
