The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 29/11/2019 by the undersigned in presence of Shri Prakash Y, Mine Manager and mining Engineer & Shri Nagraj Rao Ghorpode, Geologist.

Rule	Nature of Violation observed
11(1)	Mining operations have not been carried out in accordance with the Modified Mining Plan approved vide MMP/MECH-03(KNT)/GOA//2018-19 dated 10/08/2018 to the extent indicated below:
	(i) In the years 2018-19, exploration of 13 core boreholes upto 300m depth or
	discontinuence of ore body for each hole has been proposed to be carried
	out at earmarked place to cover the lease area and same has already been pointed out during this office's previous date of inspection and violation
	letter were issued vide letter even no. dated 31.05.2016.On your reply vide
	letter no. nil dated 8/7/2019, it has been submitted reply, that the all
	remaining 06 holes has completed and form J was also enclosed alongwith.
	However, during the inspection it has observed that, the no such balanced
	06 bore holes were drilled so far.
	Further, in the year 2019-20, 13 nos. of core boreholes were proposed to be
	drilled, however the aforesaid boreholes were also not completed so far.
	(ii) The bench geometry and pit designs for systematic and scientific mining as proposed in the above approved documents were not maintained.

45(7)(a)	It has been observed in the annual returns 2018-19, that the:-
	(i) Part V sec 3:- The Reserve and resource estimated at the end of the year 2018 -
	19 are incomplete/ false.
	(ii) Overburden as handaled in year 2018-19 were not recorded properly in
	the respective para.

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
