Sub :Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Muddapur Limestone Mine ,M/s J.K.Cement Limited situated in Village – Muddapur, Mudhol - Taluka, Bagalkot- District of Karnataka State.

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 04/03/2020 by the undersigned in presence of Shri Deepak Kalla,General Manager, Mines & Shri Sri. Venkateshwarlu. K,Mines Manager.

Rule	Nature of Violation observed
11(1)	To develop the greenbelt in the safety zone area of 7.5m all along the boundary of lease by using fast growing tree saplings with dense canopy in tune with the local biodiversity in phased wise afforestation programme as enumerated in the approved Modification in Mining Plan. However, the substantial growth of plants for aforesaid afforestation were not observed in some places.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
