विषय/Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Donimali Iron Ore Mine (ML No. 2526) over an area of 52.82 Ha located in Taranagar village, Sandur Taluka, Ballari district of Karnataka State

## महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules 2017 were found violated in your above mine during the inspection carried out by the undersigned along with Shri. H M Shiva Kumar-Assistant Mining Engineer in presence of Shri.Vuppu Lowa Raju - Mines Manager, Shri. C.V.N Reddy- Asst Manager & shri. Venkata Subbaiah Chereddy- Geologist on 23.10.2020.

Rule	Nature of violations observed
11(1)	Modified RMP along with PMCP was approved vide letter no.279/591/97/BNG dated 24.10.2017 for a period of 2017-18 to 2020-2021. The deviation observed in mining operation vis-a-vis approved document are given below:
	During the year 2019-20, 1, 00, 000 Tons of OB was handled against the proposal of 4, 05,257 Tons, there by distorting the stripping ratio. It was also observed that only 41,500 Tons of ore had been produced. Clarification on the above may be given.
45 (7)	Following deficiencies were observed in the Annual Returns submitted:  i) As per Part I, Sl No.12, in lease area (surface area) utilization at the end of the year, 5.00 Ha of area is furnished as aleady exploited & abandoned by open cast (O/C) mining. During the inspection it was observed that no part of the mining lease had been abandoned.

	<ul> <li>ii) In part V of the annual returns, 2.088 Million Tons of reserves have been furnished with average grade of 58.15% Fe, where as 1.878 Million Tons of Iron Ore (53.5 % Fe) &amp; 1.579 Million Tons of BHQ (40.89 % Fe) has been approved in the Modified mining plan as on 01.04.2020.</li> <li>iii) As per part VII in the cost of production table, DMF &amp; NMET details have not been furnished.</li> </ul>
46(a)	Notice of appointment of Geologist made under sub-rule (1) of rule 55 has
	not been received by this office.

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017. Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.
- 03. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
