विषय/Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Haraginadona Iron Ore Mine (ML No. 2352) over an area of 76.63 Ha located in Haraginadoni village, Ballari Taluka, Ballari district of Karnataka State

महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules 2017 were found violated in your above mine during the inspection carried out by the undersigned along with Shri. H M Shiva Kumar-Assistant Mining Engineer in presence of your good self & Sri S Vinodh - Manager Mining on 15.09.2020.

Rule	Nature of violations observed
11(1)	Modified RMP with PMCP was approved vide letter no.279/594/98/BNG dated 26.11.2019 for a period of 2019-20 to 2020-2021. The deviation observed in mining operation vis-a-vis approved document are given below
	It was observed that development was proposed in N 1674476 - N1674640 & E 689309 to E 689453 grids, where as development was carried in between the grids N 1674440 - N1674645 & E 689287 - E 689478, thereby deviating from the approved proposal.
35 (2)	Self assessed Star rating template report has not been filed online along with the high resolution satellite images covering the mining lease and an area of two kilometres from the lease boundary before 1 st July every year for the previous financial year.

45 (5) (b)	Monthly return which shall be submitted before the tenth day of every month in respect of the preceding month in electronic form along with a signed print copy of the same has not been submitted since March 2020.
45 (5) (C)	Annual return which shall be submitted before the 1st day of July each year for the preceding financial year in electronic form, along with a signed print copy of the same for the year 2019-2020 has not been submitted.
55	Whole time Geologist with minimum five years of professional experience of working in a supervisory capacity in the field of mining has not been appointed.

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017. Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.
- 03. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
