The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 02.03.2020 by undersigned in presence of S/Shri V.R. Patil, representative of mine owner; Sridhar Bhat, Qualified Person and other mining officials:

	during the course of inspection it was found that, at places,
	height of the working benches were maintained at 4 to 5m.

- 02. It is brought to your notice that violation of the above Rule constitutes an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within **45 (Forty Five) days** from the date of issue of this letter.
